


She provides training and consultation to schools across the US and in Canada about bullying prevention in preschool through Grade 12. She is an author of parent education, teacher training and curriculum materials including *Quit It: A Teacher's Guide on Teasing and Bullying for Use with Students in Grades K-3*, *Olweus Bullying Prevention Program Schoolwide and Teacher Guides*, *Class Meetings that Matter* and has provided assistance in development of resources for HRSA's *Stop Bullying Now!* Campaign. A teacher by training and experience, Ms. Mullin's nationally known work emphasizes linking bullying prevention themes to classroom curriculum and reducing the negative impact of bullying and gender-role stereotypes on school climate and student performance.
