Workshop Summary

This **interactive** workshop will address the legal requirements and practical strategies for an effective school/team response to bullying and harassment under the state's bullying law and federal and state civil rights laws. Workshop participants will explore the educational, social and emotional challenges faced by students with disabilities who are victims of bullying or discriminatory harassment. Additionally, participants will examine the legal requirements for imposing disciplinary and corrective measures on students on IEPs who bully or harass others. Participants will analyze case studies to learn about how effectively to utilize DESE's resource document titled, "*Addressing the Needs of Students with Disabilities in the IEP and in School Bullying Prevention and Intervention Efforts*," in developing individual and school-wide responses to bullying and harassment.

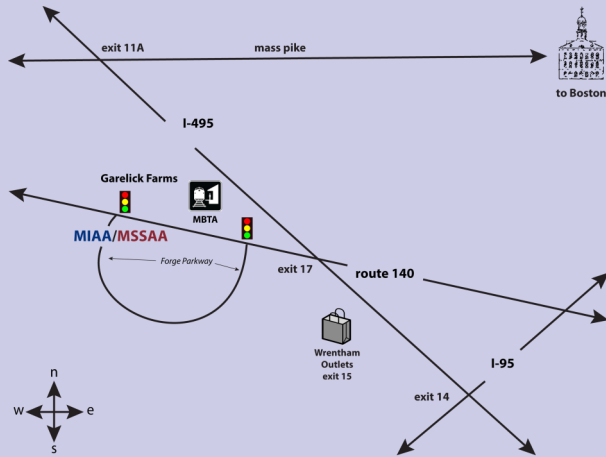
Participants will have ample opportunities for questions and answers.

Participants will:

- Learn about the legal requirements for an effective team/school response.
- Identify **strategies and techniques for effective IEP processes** for evaluating students who are vulnerable to bullying or harassment **and who are eligible for special educational services**, including students in the autism spectrum.
- Learn about how to **develop and tailor strategies and techniques for IEPs** and student safety plans to protect students with disabilities from bullying and harassment.
- Learn the design and implementation of effective whole-school approaches.

Richard Cole is a nationally recognized civil rights attorney, former Assistant Attorney General and Civil Rights Division Chief in the Massachusetts Office of Attorney General. During his 16 years in civil rights leadership positions, he developed and led the office's innovative civil rights and anti-discrimination litigation, enforcement and public-policy initiatives.
