Using case studies, participants will learn how to design an effective response tailored to the students involved and to the needs of the broader school community.

### Participants will:

- Examine the legal requirements for responding to and remedying the effects of bullying and discriminatory harassment.
- Learn how to tailor a school's response and remedies to the specific victims, perpetrators, bystanders and to the broader school community.
- Explore the broad array of disciplinary, corrective and remedial action options for addressing bullying and discriminatory harassment.
- Address disciplinary challenges, learning about the special requirements under federal civil rights laws for complying with DESE discipline regulations.
